

SUMMARY ANNUAL REPORT FOR CALIFORNIA SERVICE EMPLOYEES HEALTH AND WELFARE TRUST FUND

This is a summary of the annual report of the California Service Employees Health and Welfare Trust Fund, EIN 94-1206350, Plan No. 501, for period May 1, 2023 through April 30, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The plan has committed itself to pay certain medical, dental, vision and prescription drug claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Inc., Delta Dental of California, Liberty Dental Plan of California, Inc., HCC Life Insurance Company and Reliastar Life Insurance Company to pay certain medical, dental, life insurance, and accidental death and dismemberment benefit claims incurred under the terms of the plan. The total premiums paid for the plan year ending April 30, 2024 were \$115,541,767.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$159,446,343 as of April 30, 2024, compared to \$143,440,168 as of May 1, 2023. During the plan year the plan experienced an increase in its net assets of \$16,006,175. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$137,352,860, including employer contributions of \$129,847,880, employee contributions of \$285,640, COBRA stimulus income of \$1,341,888, realized losses of \$1,945,175 from the sale of assets, earnings from investments of \$7,805,740, and other income of \$16,887.

Plan expenses were \$121,346,685. These expenses included \$3,505,576 in administrative expenses, and \$117,841,109 in benefits paid to participants and beneficiaries.

1. an accountant's report;
2. financial information and information on payments to service providers;
3. assets held for investment;
4. transactions in excess of 5% of the plan assets;
5. insurance information, including sales commissions paid by insurance carriers, and
6. information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
